RECOMMENDED USES

For natural gas odorant (mercaptan) application. Apply directly to contaminated parts or spilled liquids. Use for decommissioning retired storage tanks. Use full strength or diluted.

OTHER USES

Carpet and fabric care, tile and concrete floors and surfaces where food spills are common (not to be used in food processing areas), refuse collection areas, urinals, toilets, bath tubs, showers stalls, rest rooms floors and surfaces, hospitals and nursing homes, public housing and shelters.

DIRECTIONS

Odor Buster may be used full strength when directly applied to stains or it can be applied by fan spray or high pressure spray diluted 4 to 6 ounces per gallon of water in spray units. For mechanized carpet cleaning equipment, use 2 ounces of Odor Buster per machine sump charge.

PRECAUTIONS:

FIRST AID

Wash thoroughly with soap and water. Wash clothing before reuse. IF IRRITATION PERSISTS GET MEDICAL ATTENTION.

INGESTION:

DO NOT induce vomiting unless directed by a physician. Contact poison control center.

Absorb in dry, inert material (sand, clay, sawdust).
